## **Management Report**

- Malini Zeigler noted the May 31<sup>st</sup> balance for community savings/CD is \$38,783.85 and operating funds \$22,759.43.
- Many homeowners called in for clarification about the violation notifications they received.

 Several homeowners notified management that their trash had not been collected. GFL Waste Management came back through the next day to collect remaining bins.

#### **Old Business**

- Fire lane painting was completed, including fire lane signs and parking Ts
- Annual Community Inspections were conducted 6/11/24. 96 violation notifications were sent out. 4 homeowners have notified management that they have complied.

#### **New Business:**

- Annual Community Inspections: follow-up inspection for violations will be on July 12 at 8am.
- A homeowner called the management office demanding that a fire lane sign place in the common area in front of his home be removed. He removed it and discarded it in a side common area. The fire marshal was notified, and he notified the state attorney general as such action is illegal. They will keep management updated on the situation.
- E-vote was memorialized for the annual audit signed engagement letter. Bonnie Seers made the motion and Angela Mayers 2nd. Unanimously passed.
- New federal rules affecting HOAs go into effect July 1 and management will provide more
  details at that time. First, towing companies will be required to get a BOD signature before they
  can tow a vehicle from the community. Second, HOA board members will have the authority to
  pass additional assessments without a community vote.
